The Solution Bundle Agreement (SBA) program addresses this and is designed for FBA solution providers who want to distribute FileMaker software with their commercial application as a product. You must be a FileMaker Business Alliance (FBA) partner to be eligible to participate in this program.

The SBA program offers FBA partners a unique and affordable way to bundle FileMaker software with a complete custom app to sell to clients. Please review the pricing and application requirements.

Licensing benefits and requirements

- You will receive a 50% margin on the following corporate licensing programs:
 - Annual FileMaker User Licensing
 - Perpetual FileMaker User Licensing
 - Annual Concurrent Connections Licensing
 - Perpetual Concurrent Connections Licensing
- Minimum initial order of 10 User Licenses and/or Concurrent Connection Licenses.
- There is a 5-license minimum for reorders. Reorder pricing is based upon the quantity of the reorder only. The pricing tier is not impacted by past or future orders.
- Each year, SBA program participants must renew or purchase a minimum of 50 User Licenses and/or Concurrent Connection Licenses per approved solution per year to stay in the SBA program.
- FileMaker, Inc. reserves the right to audit customer licensing usage.

SBA requirements

- Be an active FileMaker Business Alliance (FBA) partner.)
- Custom apps considered for the SBA program must be submitted to FileMaker, Inc. for review and approval.
 - Provide a 5-10 minute informal video demonstrating the custom app using YouTube/Vimeo/link
- Provide a link to your hosted demo app with full access permissions. Provide user name and password. It may only be modified for integration/implementation purposes (e.g. connect to other hardware and systems) and personalization purposes (e.g. client company logo for example).
- Bundle the FileMaker Platform with the approved custom app. FileMaker software purchased under SBA program cannot be sold separately from the bundled app.
- Provide sales reporting of end-user customers with each subsequent order. FileMaker, Inc. reserve the right to audit.
- Maintain your account with FileMaker in accordance with our terms by regular, on-time payment of invoices.
- Complete annual SBA agreement.
